## MEMBERSHIP

## ENTRY FEE

Entry fee is \$20 / consigned animal. All sale entry fees must be paid to the TSGRA before December 15, 2024.

## RULES AND GUIDELINES

We ask that you please review closely the rules and sifting guidelines for this sale. The primary goal of this sale is to provide a valuable experience for both buyers and sellers and a key component of that is the transfer of healthy livestock, which the rules and sifting guidelines are designed to ensure.

## SELLERS INFORMATION AND MEETING

Especially important as this is the first year of the sale, the sale committee (chaired by Darci Luensmann and Jake Thorne) are available for any questions about the format of this sale. Once all consignments are confirmed, we will be hosting a virtual meeting for all sellers to provide details about the agenda and answer any questions. At this time, we will also go over the rules of the sale and important considerations regarding the sifting process.

## COMMISSION

You are liable for a 10% commission fee and the entry fee will be extracted from the commission after the sale. *Example:* if an animal sells for \$1,000, you will pay \$80 in commission. Checks will be dispersed following the sale.

## GROUP CHOICE

Each consignor will have the option to have 2 individual lots and the rest will be sold in group-choice format. Individual rams/billies will be sold as single lots. For group choice lots, pairs or trios of rams/billies will be moved into the sale ring at one time and auctioned at a per head price. The buyer with the winning bid will have the option to take one or all at that per head price. If the entire lot is not taken, then bidding will restart for the remaining sires. The size of those groups will be determined by the sale committee at a later date.
